- **2. Science at the Law Library:** Dean Rowan and Marlene Harmon from Berkeley Law Library talked about collections and reference relevant to us as science library staff.
  - a. Collection driven by faculty and their work
  - b. When working with students in clinical setting or writing workshop, the law library tries to introduce them to main campus library resources
  - C. Shared collection goes both ways
    - Will consider duplicating print between law & other collections when faculty specifically requests it
  - d. Technology, data sciences, information sciences more common in law collection than life sciences
  - e. Continuing legal education: Practicing Law Institute Plus (PLI+) could be useful for patrons who want to view current scientific issues via a legal perspective
    - i. Might be especially useful for patent law, Al
  - f. Often help grad students (and some undergrads) especially from social sciences, computer science who are well-grounded in their primary subject and want to explore law and policy related to that subject
    - i. Often have to help them tailor back their expectations
  - g. Law library is open to the public

- Some databases are password protected but others can be accessed from terminals onsite
- ii. Reference services are open to the public, checkout is not
- iii. Chat service is restricted to Berkeley Law faculty and students
- iv. Can provide research appointments to non-law students via this form, will help as able
- h. Collection of practical pro se materials near circ desk can be used when preparing for court
  - i. Students rarely know about it
  - ii. Migrating to electronic due to expense
- i. When print moves to electronic sometimes it makes it harder for the public to access.
