- Open Access and Data publishing requirements: Anna Sackmann, Tim Vollmer, Erin Foster (11-11:30) shared a [presentation](#) on this topic. The 2022 OSTP Memorandum on *Public Access to Federally Funded Research* (aka the “Nelson Memo”) revises the 2013 OSTP policy. It has revised publishing requirements for recipients of federally supported research and data with an aim to ensure free, immediate and equitable access to federally funded research. The former policy covered agencies sponsoring grants over 100 million dollars but now all agencies are included. The 2013 OSTP memo allowed for an embargo but this will no longer be the case. Data should also be stored and immediately accessible as well as a Data Management Plan (DMP). The new policy includes conference proceedings and book chapters. UC authors can comply via e-scholarship or a publisher’s OA website, e.g. by participating in UC system-wide OA journals. Erin noted agencies previously exempt (such as the NEH) are working on their policies and RDM staff are considering how to advise people in this new framework. Some agencies have their own publications repositories but data repositories are not typically specified. Dryad is an option for UC authors. The size of data and its characteristics are considerations. A “good” repository will have characteristics: such as a strong infrastructure, object management, robust technology etc. We support researchers to navigate policies but we do not help them deposit or “enforce” deposits or answer questions about grant money (handled by UCB Program officers).
- Announcements
 - Budget update
 - End of year acquisitions - it will be “status quo” which means a cut. The Library budget team will meet in July and the annual budget forum will be held in late August or September. LBS is working on paying invoices but because of delays, there may be some carry forward. LBNL (Lawrence Berkeley National Lab) cost share issues have come up. Content acquired at the end of year includes
 - De Gruyter e-book package of 27,000 e-books at a large discount because 10,000 titles we already have in print. Also purchased 2024 content for Harvard, Stanford, Columbia, Yale, Chicago, De Gruyter, Cornell, Princeton, Texas, and Hawaii and will continue for the next 3 years.
 - Lexis API for three years.
 - EastView Global Census Archive for various countries in Southeast Asia. This includes publications and GIS shape files
 - Adam Matthews: 1980's Culture and Society, Amnesty international Archives, additional modules for Colonial America, and Conflict in Indochina: Foreign Office Files for Vietnam, Cambodia and Laos, 1959-1979.
 - There have been some delays in funding some outsourced catalog records.
